‘조세심판통계연보’가 조세심판업무에 대한 이해를 높이고, 나아가 조세심판제도를 발전시키는데 유용한 자료가 되기를 기대합니다.



최근 조세심판원은 행정심(行政審) 단계 조세불복사건의 대부분을 담당하는 등 그 역할이 확대되고 있으며, 한정된 인원 등 어려운 환경 속에서도 신속하고 공정한 결정을 위해 부단한 노력을 기울이고 있습니다.

그 노력의 일환으로 조세심판원은 지난 2015년 변화하는 조세환경에 발맞춰 납세자들과 과세관청이 조세심판원에 거는 기대와 요구에 부응하기 위해 설립 이후 최초로 조세심판통계연보를 발간한 바 있습니다.

조세심판통계연보는 심판청구에 관한 각종 통계뿐만 아니라 조세심판 결정과정의 전반적인 모습을 보여줌으로써 납세자, 과세관청 및 국민들께 유용한 정보를 제공하여 조세심판의 투명성 및 신뢰성을 제고하는데 기여하고 있습니다.

‘2015 조세심판통계연보’는 지난 해 새로 도입한 국선심판청구대리인 제도 운영현황 등의 통계자료를 추가하였고, 조세심판관합동회의 운영현황 및 비상임심판관 지정현황 등의 통계자료를 내용적인 면에서 보완하여 최초 발간시 미흡했던 부분들을 개선하였습니다.

아무쪼록 공정하고 투명한 조세심판원이 되기 위한 노력이 담긴 ‘조세심판통계연보’가 조세심판업무에 대한 이해를 높이고, 나아가 조세심판제도를 발전시키는데 유용한 자료가 되기를 기대합니다.

Preface

The roles of Tax Tribunal have been expanded, and it makes ceaseless efforts to make a ruling swiftly and fairly amid difficult situations caused by a lack of manpower.

As part of its effort, Tax Tribunal published Annual Report on Tax Tribunal Statistics for the first time last year in order to meet expectations of taxpayers and tax offices on Tax Tribunal in line with changing tax environment in 2015.

The Annual Report on Tax Tribunal Statistics provide useful information to taxpayers, tax offices and the general public by disclosing various statistics on appeal to tax tribunal in addition to the entire process of making a ruling so that it can contribute to improving transparency and reliability of appeal to tax tribunal.

‘2015 Annual Report on Tax Tribunal Statistics’ added statistical data on the current state of systematic operation of Public Representative to Appeal to Tax Tribunal and supplemented statistical data on the current state of operation of Joint Meeting of Adjudicators and designation of Non-Standing Adjudicator while complementing the first report in terms of contents.

I sincerely hope that ‘Annual Report on Tax Tribunal Statistics’ containing efforts to realize fair and transparent Tax Tribunal will be useful in furthering understanding about tax trial and advancing tax tribunal system.

이용을 위한 참고사항

- 조세심판통계연보는 조세심판과정의 투명성·공정성을 제고하고 조세심판제도의 발전을 위한 참고자료로서, 조세심판통계연보의 각종 통계는 조세심판청구와 관련된 기초자료를 토대로 조세심판원에서 정리·집계한 것입니다.
- 국무총리 조세심판원은 「통계법」 제15조에 따른 지정된 통계작성지정기관이 아니므로 조세심판통계연보는 「통계법」에 따라 정식으로 승인된 국가통계는 아닙니다.
- 수록된 통계는 각 연도별로 1. 1.~12. 31.을 그 대상기간으로 하여 집계하였고, 인원 현황 등의 기본 통계는 각 연도말을 기준으로 집계하였습니다.
- 청구내용이 여러 세목과 관련된 경우 ‘대표세목’을 기준으로 집계하였습니다.
- 결정 유형으로 ‘인용’은 ‘전부 인용(취소)’과 ‘일부 인용’을 합한 것을 의미합니다.
- 결정 유형으로 ‘재조사’는 2014년부터 구분·관리하였으며, 2013년까지 ‘재조사’는 ‘인용’으로 분류하였습니다.
- 통계표 작성 시 해당 값이 ‘0’인 경우에는 ‘-’으로 표시하였습니다.
- 국가 간 ‘상호합의’가 진행 중인 건은 2014년부터 구분·관리하였고, 2014년 이후 처리기간 계산시(처리건수는 포함) 이를 제외하였으며, 2008년~2013년까지는 이를 모두 포함한 수치입니다.
- 모든 자료수치는 세부항목과 합계를 각각 반올림하였으므로 세부항목의 합이 합계와 일치하지 아니하는 경우도 있습니다.
- 조세심판통계연보에 수록된 통계 중에서 개선·보완할 사항에 대하여 의견을 보내주시면 다음 연도 조세심판통계연보 편찬에 활용하겠습니다.

Guide for use of Statistics

- Annual Report on Tax Tribunal Statistics is reference material for enhancement of transparency and fairness of tax tribunal and development of tax tribunal systems, and various statistical data in Annual Report on Tax Tribunal Statistics were established based on basis material related to appeal to tax tribunal as collected and organized by Tax Tribunal.
- Since Tax Tribunal under the Prime Minister's Office is not a statistics agency designated in accordance with Article 15 of Statistics Act, Annual Report on Tax Tribunal Statistics is not an official national statistics in accordance with Statistics Act.
- Included statistics cover the period from January 1 to December 31 in each year, and basis statistics including the number of persons was compiled based on the end of the year.
- If the contents of appeal pertain to various tax items, they were compiled based on 'representative tax item.'
- 'Citation' in type of adjudication combines 'entire citation (cancellation)' and 'partial citation.'
- 'Re-examination' in type of adjudication has been distinguished and managed since 2014, and it had been classified as 'citation' until 2013.
- If pertinent value is '0' at a time of compiling a statistical chart, it was indicated as '-'.
- On-going cases pertaining to 'mutual agreement' by governments have been distinguished and managed since 2014, and they were excluded at a time of calculation of the handling period (including the number of handling cases) after 2014. Data pertaining to 2008 through 2013 include all of them.
- Since all data on detailed items and total were rounded off, the sum of the detailed items might not correspond with the total.
- If you find anything that needs to be improved with regard to statistics included in Annual Report on Tax Tribunal Statistics, please let us know, so that your opinion can be used in publishing Annual Report on Tax Tribunal Statistics next year.




